	<p>5. <u>Judicial Review</u></p> <p>Judicial Review (JR) is a legal remedy to test the validity of rules and regulations against higher rules and regulations through the judiciary. In Indonesia the JR of a law against the 1945 Constitution is carried out by the Constitutional Court (MK). Meanwhile, the JR of rules and regulations below a law (Presidential Regulation, Ministerial Regulation, Governor Regulation, Regent/Mayor Regulation and other regulations) against a law is carried out by the Supreme Court of the Republic of Indonesia (MA). For that purpose, we are here to provide legal advice and legal remedies to conduct a JR for individuals or legal entities whose rights are violated by the existence of rules and regulations, either laws or regulations below a law.</p>
